Case Summary: (type of Hearing and just brief introduction to help the reader) Tacking in the zone

Procedural Matters, (Conflicts of Interest,, parties not present, extending time limits)

Facts found:

- 1. On the first beat to windward, ESP 7 on close hauled course was approaching the mark on starboard tack and fetching the mark.
- 2. In the zone, SUI 1 passed head to wind from port to starboard and was then fetching the mark.
- 3. SUI 1 completed her tack clear ahead of ESP 7 as her bow passed the mark.
- 4. ESP 7 was higher speed than SUI 1 and did not alter her course.
- 5. There was contact between ESP 7's bow and SUI 1's stern to leeward of her rudder and about 1 second after SUI 1 completed her tack.
- 6. Immediately before the contact ESP 7 became inside overlapped to leeward of SUI's rudder.
- 7.SUI 1 took a Two-Turns penalty 45 sec after rounding the offset mark. There were no boats preventing SUI getting well clear and taking her penalty sooner.

Conclusion & Rules:

After SUI 1 completed her tack, she failed to initially give ESP 7 room to keep clear and broke RRS 15. By failing to give mark room, SUI 1 broke RRS 18.3. By not avoiding contact SUI 1 broke RRS 14.

From the moment it was clear that SUI 1 was not giving room or mark room, it was not reasonably possible for ESP 7 to avoid contact and therefore ESP 7 did not break RRS 14.

SI 1.8 allows a boat to delay a penalty for an incident in the zone around mark 1 until she has passed mark 1a. However, SUI 1 delayed her penalty another 45 seconds and failed to take her penalty as soon as possible after passing mark 1a.
